Healthcare Case Studies



Salveo Specialty Pharmacy was formed to acquire and manage high quality specialty pharmacies throughout the United States servicing patients with chronic conditions. Petra backed the management team to pursue an acquisition strategy in partnership with coinvestors Three Arch Partners, New Spring Capital and Sofinnova Ventures. In addition to providing creatively structured capital, Petra served on the Board of Salveo and was instrumental in providing strategic direction to the Company. Petra also recruited a former CVS Caremark EVP of Specialty Pharmacy Services to serve as an industry expert on the Board of Directors. Salveo was the recipient of the 2015 SBIA Portfolio Company of the Year Award and was eventually acquired by publicly-traded pharmacy benefit manager Catamaran.



New Century Hospice, based in Dallas, was formed to acquire and manage high quality hospice operations throughout the United States. The management of New Century has over 50 years experience in the industry including co-founding Odyssey Hospice, the largest pure play hospice in the U.S. Petra invested \$8 million of subordinated debt and \$4.7 million of equity to support the Company's growth plans. In January 2016, New Century was acquired by Curo Health Services, a portfolio company of Thomas H. Lee Partners.



Santé Pediatric Services, based in Fort Worth, TX, is the largest independent pediatric therapy provider in Texas, providing physical, occupational and speech therapies in either a home or clinic setting. Petra invested \$5.4 million of subordinated debt and equity in support of the buyout of the company in partnership with Enhanced Equity Fund and Transition Capital Partners. Santé was acquired in 2012 in a strategic transaction with Epic Health Services.



SpecialtyCare (SCSG), based in Nashville, provides outsourced clinical services to hospitals and health systems nationwide. SCSG provides outsourced perfusion, autotransfusion, anesthesia technician, surgical blood management, intra-operative monitoring, and endoscopy services. Petra invested \$14 million of subordinated debt in partnership with equity from Altaris Capital Partners to recapitalize the Company and to support SpecialtyCare's acquisition strategy. SpecialtyCare was recapitalized by American Securities in 2011.
